#### SECTION 4: FIRST AID MEASURES

##### 4.1 Description of first aid measures:

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the SDS of this product.

**SECTION 5: FIREFIGHTING MEASURES****5.1 Extinguishing media:**

If possible use polyvalent powder fire extinguishers (ABC powder), alternatively use foam or carbon dioxide extinguishers (CO<sub>2</sub>). IT IS RECOMMENDED NOT to use full jet water as an extinguishing agent.

Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection. Above all prevent the formation of any vapour-air flammable mixtures, through either ventilation or the use of an inert medium. Destroy any source of ignition.
